General Information

- We advise you limit washing the leotards where possible, to avoid wear/damage. Please contact us for specific instructions/advice on washing should you need.
- Do not wear the leotard for longer than is required (e.g. travelling to/from an event).
- Do not consume food or drink (other than water) while wearing the leotard.
- It is recommended that bodysuits/under leotards are worn with our hire leotards
- Any intention to take the leotards outside the UK must be notified in writing 4 weeks before the event. Although unlikely, we reserve the right to decline overseas use.
- The hire leotards remain the absolute property of Derivative Leotards. The customer has no right, title, or interest, except that it is hired for an agreed period.
- It is the responsibility of the Hirer to check upon receipt of the leotards that they are in good condition. The Hirer will be held liable for any defects or deficiencies unless the Hirer has notified us in writing before signing the agreement.
- The Hirer shall not assign, transfer or otherwise part with possession of the leotards beyond that which is reasonably necessary.

Temporary Alterations

The Hirer is allowed to carry out alterations, provided they are temporary and are removed before their return. This includes sewing of country flags when representing a national team, and tacking skirts down. Loose stones can be resecured if necessary.

Loss or Damage

If you damage the items during your hire, on their return we will inspect them and a preliminary quotation for repair/replacement will be obtained. We understand leotards will overtime pick up the odd fault. However, major faults and obvious neglect of use under your care will be treated as damage and you will be charged accordingly.

In the event of any loss or theft, please inform us immediately and report it to the police.

The Hirer shall not carry out or attempt repairs to damaged items without prior written permission from Derivative Leotards. No permanent modifications can be made to items.

***International Returns:** Select the courier as appropriate, ensuring the items are insured up to their full value. Any potential customs fees must be covered upfront.

Requirements

Leotards are assigned to 1 partnership only. Use for multiple routines by the same partnerships is permitted. If the partnership changes, notify us in writing immediately, to transfer the agreement.

- *£60.00 per leotard per event surcharge if not followed*

Leotards must be returned on or before the agreed hire end date, using the details above.

- *£10.00 per leotard per week items remain unreturned to the Company*
- *£15.00 per leotard if returned incorrectly e.g. using the incorrect service*
- *Full Value of the leotards if not returned to our warehouse within 2 months (31st Sept 2025)*

Please note the requirements above are the same as our standard 7-day/28-day hires.
